GUIDELINES FOR PAPER PREPARATION

We invite authors to submit the title and abstract of their paper by October 20, 2025. The title and abstract should be written in one of the official languages of Bosnia and Herzegovina and in English, or only in English (title in 14 pt bold font).

We especially encourage submissions from participants and speakers representing organizations advocating for persons with disabilities, minority and marginalized groups, students from socio-economically disadvantaged backgrounds, and youth from rural areas, with the aim of ensuring an inclusive and diverse academic dialogue.

The abstract should briefly address the following questions: What were the motivations/objectives of the research? What was done? How was it done? What are the main results? What is the significance of the results?.

Please summarize your answers in a maximum of 200 words. The abstract should be written as a single-column text, using Times New Roman font, size 12, single line spacing, with 2.5 cm margins.

The following information should be provided: paper title, author's full name, name of the organization, postal address, phone number, fax number, and email address. At the end of the abstract, list up to five keywords.

Along with the notification of abstract acceptance, authors will receive guidelines for paper writing. Full papers should be submitted by November 24, 2025, via the online platform: https://zriut.com/. Submitted papers will be peer-reviewed by reviewers, and the Organizing Committee will notify authors of paper acceptance by December 1, 2025. The presentation, prepared in accordance with the official Conference template, should be submitted no later than December 8, 2025.

Accepted papers will be published in the Proceedings, which are indexed in CEEOL (https://www.ceeol.com/) and INDEX COPERNICUS (https://journals.indexcopernicus.com/).

Papers and abstracts submitted after the deadline will not be considered or accepted!
